the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Levis L. Gilstrap

All that piece, parcel or lot of land, situate, lying and being on the West Side of Donnan Road, in Greenville County, South Carolina, known and designated as the Southern portion of Lot #9, as shown on Plat No. #2 of the property of W. S. Bradley, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book O, at Page 169, and having according to said plat and a recent survey made by R. K. Campbell, August 2, 1958, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the West side of Donnan Road at joint front, corner of Lots #9 and #45, and running thence along the line of Lot #45, N. 88-10 W., 342 feet to an iron pin; thence N. 1-50 E. 110 feet to an iron pin; thence S. 88-10 E., 342 feet to an iron pin on the West Side of Donnan Road; thence along the West side of Donnan Rd., S.1-50 W., 110 feet to the point of beginning.
