sum of **TWELVE THOUSAND EIGHT HUNDRED AND NO/100 (\$12,800.00)**----- dollars, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto **WILLIAM J. LESLIE AND JO B. LESLIE, their Heirs and Assigns, forever:**

All that piece, parcel or lot of land situate, lying and being at the South-western corner of the intersection of Staunton Bridge Road and Patti Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as a portion of Lots Nos. 1 and 2 as shown on a plat of Staunton Heights, prepared by Dalton & Neves, Engineers, dated February, 1964, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book RR at page 167, and being known and designated as Lot No. 2 as shown on a plat of Revised Portion of Staunton Heights, prepared by Dalton & Neves, dated May, 1964, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book FFF at page 131, and having according to the last mentioned plat, the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Patti Drive at the joint front corner of Lots Nos. 1 and 2, and running thence with the line of Lot No. 1 S. 13-0 W. 144.5 feet to an iron pin in the subdivision property line; thence with the subdivision property line S. 81-33 E. 80.48 feet to an iron pin on the Northwestern side of Staunton Bridge Road; thence with the Northwestern side of Staunton Bridge Road N. 41-08 E. 130.7 feet to an iron pin; thence with the curve of the intersection of Staunton Bridge Road and Patti Drive, the chord of which is N. 17-55 W., 25.8 feet to an iron pin on the Southern side of Patti Drive; thence with the Southern side of Patti Drive N. 77-0 W. 128.6 feet to the point of beginning.
