

Being the same property conveyed to the Grantors by deed recorded in Deed Book 742 at Page 465.

PARCEL NO. 7

All that certain lot of land lying in the State and County aforesaid on the northern side of Woodruff Road at or near the intersection of the said road with Laurens Road and having the following metes and bounds, to-wit:
