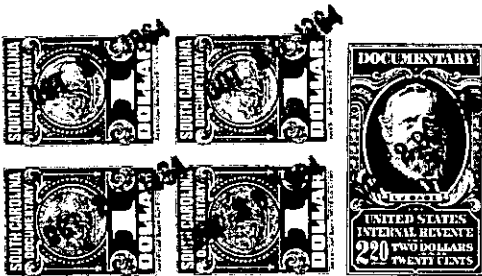

A Corporation chartered under the laws of the State of South Carolina and having a principal place of business at Greenville, State of South Carolina, in consideration of Nineteen Hundred and no/100 - - - - - (\$1900.00) - - - - - Dollars, the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto L. M. Brown, his heirs and assigns, forever:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina and being shown as Lot No. 2 on a plat of Farmington Acres, recorded in the RMC Office for Greenville County in Plat Book RR, Pages 106-7 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of White Horse Road at the joint front corner of Lots 1 & 2 and running thence with the common line of said lots N. 51-12 E. 206.6 feet to an iron pin in the line of Lot No. 3; thence with the line of Lot 3 N. 38-48 W. 105 feet to an iron pin on the southerly side of Claxton Drive; thence with said Drive S. 51-12 W. 114.3 feet to an iron pin; thence around a curve at the intersection of White Horse Road and Claxton Drive (the chord of which is S. 23-14 W.) 44.2 feet to an iron pin on the easterly side of White Horse Road; thence with said Road S. 4-42 E. 101.2 feet to the point of beginning.

The above mentioned lot is conveyed subject to the recorded restrictions applicable to Farmington Acres and to the set-back line as shown on said plat.
