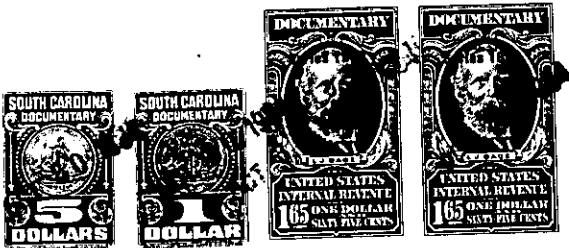

BEGINNING at an iron pin on the southeasterly side of Cherrylane Drive at joint front corner of Lots Nos. 61 & 62 and running thence with the line of said lots S. 37-15 E. 150 feet; thence S. 52-45 W. 90 feet; thence N. 37-15 W. 150 feet to an iron pin on Cherrylane Drive; thence with Cherrylane Drive N. 52-45 E. 90 feet to the point of beginning.

ALSO, that certain other lot of land being shown as Lot No. 70 of Farmington Acres and, according to said plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwesterly side of Shubuta Drive at joint front corner of Lots Nos. 70 and 71 and running thence with the line of said lots N. 37-15 W. 150 feet; thence N. 52-45 E. 90 feet; thence S. 37-15 E. 150 feet to an iron pin on Shubuta Drive; thence with Shubuta Drive S. 52-45 W. 90 feet to the point of beginning.

This conveyance is made subject to the set-back line and easements as shown on said plat and the recorded restrictions applicable to Farmington Acres.
