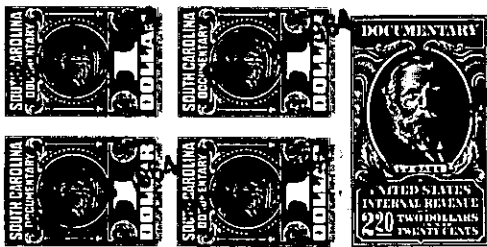
KNOW ALL MEN BY THESE PRESENTS, that PIEDMONT LAND CO.

A Corporation chartered under the laws of the State of SOUTH CAROLINA and having a principal place of business at GREENVILLE, State of SOUTH CAROLINA, in consideration of

EIGHTEEN HUNDRED NINETY FIVE AND NO/100-----(\$1895.00)-----Dollars, the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto J. H. WATSON AND GAIL B. WATSON, THEIR HEIRS AND ASSIGNS:

ALL that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot #70 on the Western side of Homestead Drive, of a subdivision known as Homestead Acres, as shown on a plat prepared by J. Mac Richardson, Engineer, dated November 1959, and is recorded in the R. M. C. Office for Greenville County in Plat Book RR at Page 35, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Homestead Drive, joint front corner lots #69 and #70, and running thence along the line of these lots, S. 87-50 W. 180 feet to an iron pin; thence S. 2-10 E. 120 feet to an iron pin at the joint rear corner lots #70 and #71; thence along the joint line of these lots, N. 80-12 E. 187.7 feet to an iron pin on the western side of Homestead Drive; thence along the western side of Homestead Drive, which line is curved the following courses and distances, to-wit: N. 7-21 W. 72.9 feet to a concrete monument; thence continuing N. 2-10 W. 22.1 feet to an iron pin, point of beginning.
