the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Charles A. Vernon, His Heirs & Assigns, forever:

All that piece, parcel or lot of land in Bates Township, County of Greenville, State of South Carolina, containing 3.5 acres, more or less, and having the following metes & bounds;

BEGINNING at a stone and iron pin, corner of lands of Kalo Brown Estate, Troy McAlister and Grantors' and running thence N. 14-30 W 231 feet to iron pin; thence N 50-00 W. 44.7 feet to iron pin, corner H. Y. Hawkins land; thence N 50-05 E. 330.5 feet to iron pin at South Beaverdam Creek; thence up creek, the creek being property line, S 34-30 E 541 feet to iron pin; corner with Dr. James Barnett and Kalo Brown Estate; thence S 87-30 W 466 feet to beginning corner.

It is also agreed that the Grantors' retain the right to build and maintain a fence on the west bank of the S. Beaverdam Creek for one-half the distance along creek and the buyer or Grantee shall have right to fence one-half the distance on the East bank of creek.
