All that certain piece, parcel or lot of land in Greenville County, State of South Carolina, on the western side of Balfer Drive, near the City of Greenville, being shown as lot No. 88 on a plat of SECTION III, WADE HAMPTON GARDENS, recorded in the RMC office for Greenville County in Plat Book YY at Page 179, and described as follows:
