in consideration of the sum of One Thousand and no/100 (\$1,000.00) in the State aforesaid, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said W. E. SHAW, INC., its successors and assigns, forever:

ALL that lot of land, situate in Greenville County, South Carolina, on the Northwest side of Queensbury Drive being shown as Lot 4 on plat of Section II of Canterbury Hills, made by Piedmont Engineering and Architects, March 19, 1964, recorded in the R.M.C. Office for Greenville County in Plat Book XX, Page 191, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northwest side of Queensbury Drive at the joint front corner of Lots 3 and 4 and runs thence along the line of Lot 3, N. 43-06 W., 160 feet to an iron pin; thence S. 46-54 W., 100 feet to an iron pin; thence with the line of Lot 5, S. 43-06 E., 160 feet to an iron pin on the Northwest side of Queensbury Drive; thence along Queensbury Drive, N. 46-54 E., 100 feet to the beginning corner.

THIS is a portion of that property inherited by the Grantor and his mother, Juanita W. Gibson, from Joe L. Watkins as will more fully appear by reference to Apartment 618, File 60, for Greenville County, S. C. Subsequently, Juanita W. Gibson conveyed her interest in the above property to the grantor by deed recorded in Deed Book 616, Page 509, R.M.C. Office for Greenville County, S. C.

THIS property is conveyed subject to the restrictions applicable to Section II, Canterbury Hills, recorded in the R.M.C. Office for Greenville County, S. C., in Deed Book 650, Page 213.

GRANTEE is to pay 1964 taxes.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and its successors Heirs and Assigns forever.

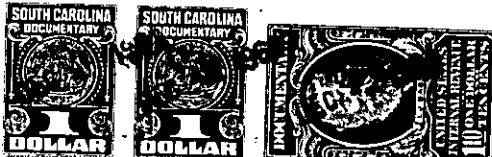
