A Corporation chartered under the laws of the State of South Carolina, in consideration of ----- (\$7,000.00)-----

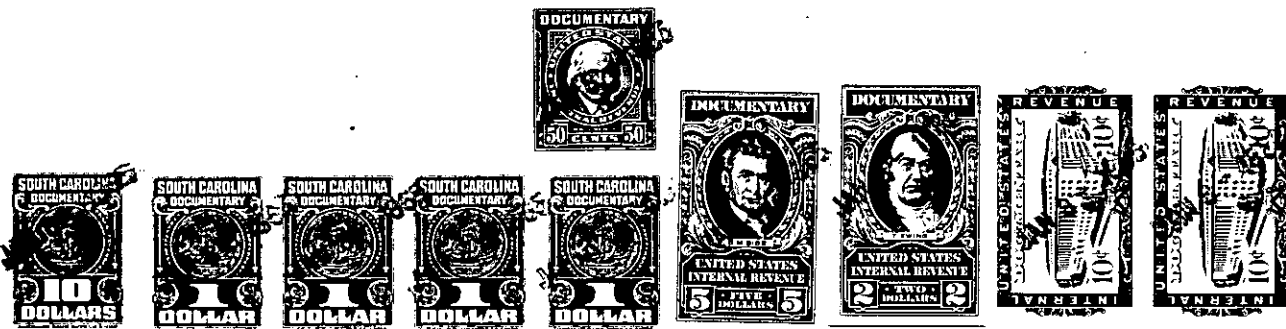
Seven Thousand and no/100 -----Dollars,  
the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto **J. ALVIN GILREATH, his Heirs and Assigns:**

ALL that lot of land in Greenville County, South Carolina known and designated as Lot Number Thirty-Eight (38) of Section One (1) of Chanticleer, Inc. as shown by a plat thereof made by R. K. Campbell, dated September 29, 1962, and recorded in the R.M.C. Office for Greenville County in Plat Book YY at page 97; and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the northern side of East Seven Oaks Drive at the joint front corner of Lots 38 and 39 and running thence with the northern side of East Seven Oaks Drive, **S. 74 - 47 E.**, 60 feet to a pin; thence still with the northern side of East Seven Oaks Drive, **S. 85 - 14 E.**, 60 feet to a pin, joint front corner of Lots 37 and 38; thence with the line of Lot 37; **N. 4 - 14 E.**, 205 feet to a pin in the rear line of Lot 27; thence with the rear line of Lot 27, **S. 84 - 01 W.**, 87 feet to a pin at the common rear corner of Lots 26, 27, 38 and 39; thence with the line of Lot 39, **S. 14 - 22 W.**, 186.6 feet to the beginning corner.
