the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release J. T. Garrett, his heirs or assigns:

All that piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina about  $1\frac{1}{2}$  miles from the Town of Simpsonville, on the western side of the Neely-Ferry Road, and containing 8.5 acres, more or less, and being what remains of a 12 acre tract of land conveyed to Harold Holcombe by Duling Land by deed dated Feb. 12, 1947, recorded in Deed Book 307, Page 374. Of the original 12 acres a lot of 3.5 acres was conveyed away by the said Harold Holcombe to Harold Bagwell and Frances E. Bagwell. Described by courses and distances the 12 acres percel is as follows: distances the 12 acre parcel is as follows:

BEGINNING at an iron pin in the center of the Neely Ferry Road at corner of lands of C. V. Jones and Duling Land, and running thence along the center of said Neely Ferry Road. S. 14 3/4 E. 2.84 chains to an iron pin at the corner of tract belonging to Hoyt Bagwell; thence still with the center of said road in a southwesterly direction about 17.00 chains to a stone in center of a branch at corner of property of Hoyt Bagwell, Jim Garrett and others; thence up the branch as the line about 17.00" chains to a stone in said branch at corner of land of C. V. Jones; thence along the line of his property N. 79 3/4 E. 6.48" chains to a stone; thence still with the line of C. V. Jones property, N. 84-00 E. 7.20" to the beginning corner. EXCLUDED from this course and distance description to the beginning corner. EXCLUDED from this cour is the Bagwell lot which is described as follows:

BEGINNING in the center of a bridge which is also the center of the Neely Ferry Road on lands of Abercrombie and running thence N. 36-52 W. 33.5 feet to water oak; thence N. 4 E. 330 feet to a corner in or near creek; thence N. 26-45 W. 226.3 feet to a pin; thence N. 69-47 E. 212.5 feet to a pin; thence S. 39-42 E. 384 feet to a pail in center of the Neely Ferry Road; thence along said Neely 384 feet to a nail in center of the Neely Ferry Road; thence along said Neely Ferry Road S. 38-23 W. 321.2 feet to nail at bend in road; thence continuing along said Road S. 60-06 W. 170.3 feet to beginning corner, and being the same tract of land conveyed to grantors by Harold Holcombe by deed recorded in Deed Book 530, at page 192 in the Greenville County R. M. C. Office.
