

DISCLAIMER

Statement of Disclaimer and Renouncement of Bequest and Devise made this 30th day of September, 1964, by and on the part of John Jay Iselin of McLean, Virginia, Fannie H. Iselin (Cromwell) of Greenville, South Carolina, Eleanor Jay Iselin (Rohrbaugh) of Washington, D. C., Richard Duane Iselin of Philadelphia, Pennsylvania, William Jay Iselin of Moncks Corner, South Carolina,

WITNESSETH:

WHEREAS, Marion P. Brawley, Jr., died testate a resident of Moncks Corner, South Carolina, on January 4, 1964 leaving a Last Will and Testament dated 19 December, 1956, which has been duly admitted to probate in Charleston County, South Carolina, and

WHEREAS, more than six months has elapsed and no other will or codicil of said Marion P. Brawley, Jr., has been offered for probate as required under the provisions of the South Carolina Code of Laws, 1962, and

WHEREAS, under Item III of said Will, said Marion P. Brawley, Jr., made a conditional devise of all his residuary estate to the undersigned, his stepchildren, providing, in part:

"If, for any reason, my stepchildren should fail or refuse to accept this devise and bequest, then it is my will that the property included herein shall be divided equally between my brother, Francis Poe Brawley, and my sister, Patricia Brawley Rose, share and share alike, the child or children of a deceased parent to take the parent's share, per stirpes. My stepchildren shall be under no duty or compunction whatever to refuse or fail to accept this devise and bequest, but their circumstances, financially, may perhaps motivate such a decision, but as to this they shall be the sole judges, any such decision on the part of those who may have reached twenty-one (21) years, to be binding on those who have not.", and

WHEREAS, the undersigned stepchildren of said Marion P. Brawley, Jr., recognizing that they are under no duty or compunction whatever to refuse or fail to accept such devise and bequest, have nevertheless, separately and unanimously, reached the decision not to accept such devise and bequest under said Will,

NOW, THEREFORE, In consideration of the premises, and the circumstances, the undersigned do hereby refuse and decline to accept any devise or bequest under the Will of said Marion P. Brawley, Jr., and do unconditionally and without qualification disclaim and renounce forevermore any claim to, or interest in, any of the property, real or personal, of Marion P. Brawley, Jr., deceased and each does bind himself (or herself) and his (or her) heirs, executors, administrators and assigns, forever, to this disclaimer.
