ALL that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot #18, of a subdivision known as Homestead Acres, as shown on a plat prepared by J. Mac Richardson, Engineer, dated November 1959, and recorded in the R. M. C. Office for Greenville County in Plat Book RR at Page 35, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern edge of Homestead Drive, the joint front corner of lots #18 and #19, and running thence along the line of these lots, S. 53-55 W. 217.8 feet to an iron pin in the property line; running thence S. 32-13 E. 90.2 feet to an iron pin at the joint rear corner of lots #18 and #8; running thence along the line of lots #8 and #7, N. 53-55 E. 223.1 feet to an iron pin on the southern edge of Homestead Drive; running thence along the southern edge of Homestead Drive, N. 36-05 W. 90 feet to an iron pin, point of beginning.
