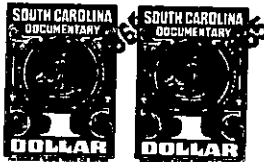

All that lot of land, County of Greenville, State of South Carolina, known as Lot 151, Fairfield Drive, in the Subdivision of Glendale, recorded in Plat Book "QQ", Page 76 in the R. M. C. Office for Greenville County, and having, according to said plat, the following metes and bounds, to-wit:
