in consideration of Five Hundred and Eighty Five & no/100 (585.00) Dollars,

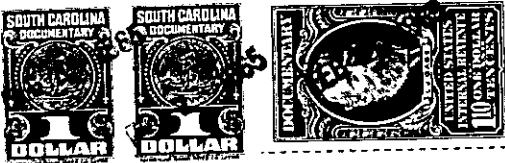
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

W.D. Shedd, His heirs and assigns forever:
All that piece, parcel or Lot of land in Gantt Township, being known and designated as Lot No. 58, of a subdivision known as Elizabeth Heights, as shown by a plat thereof, dated May 1, 1956 by Madison H. Woodward, Recorded in the R.M.C. Office for Greenville County in Plat Book KK, at page II, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on Satterfield Drive, joint front corners of Lots nos. 57 and 58 and running thence along the line of said Lots, N. 16-10 E. 150 feet to an iron pin rear corners of Lots Nos. 41 and 42; thence running with rear line of Lot 41, N. 73-50 W. 75 feet to iron pin rear corner of Lot 59; thence running with line of said Lot, S. 16-10 W. 150 feet to iron pin on Satterfield Drive; Thence running with said Drive, S. 73-50 E. 75 feet to iron pin at point of beginning.

No residence to cost less than Seventy Five Hundred Dollars. (7500.00) Shall be erected on said Lots; No residence shall be erected on any Lot unless said Lot has fifty feet (50) or more frontage; no resident shall be built on any Lot nearer than Thirty feet (30) to the front line; No outside toilets permitted and sewage to be disposed of by approved septic tanks; No business buildings shall be erected on any Lot other than lots fronting on Staunton Bridge Road.

This conveyance is subject to all easements and rights of way of record.
