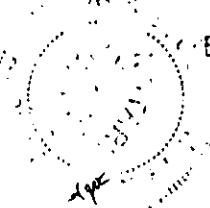

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Simon L. Beerstein, his heirs and assigns forever;

Our entire interest in the interest of our deceased daughter, Martha Duckworth Beerstein, in the property described as follows:

All that piece, parcel or lot of land in the State and County aforesaid, being designated as the Southern half of lot No. 55 on plat of Super-Highway Home Sites recorded in the R.M.C. Office for Greenville County in Plat Book "P" at page 53 and having, according to said plat and a more recent survey of property of Simon L. Beerstein, dated January 15, 1955, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Shadow Lane at the joint front corner of lot Nos. 55 and 54 and running thence along the joint line of said lots S. 88-00 E. 125 feet and S. 54-30 E. 145 feet to an iron pin; thence N. 43 E. 341.3 feet to an iron pin; thence in a new course through the approximate center of lot 55, N. 88-22 W. 470.8 feet to an iron pin on the Eastern side of Shadow Lane; thence with Shadow Lane S. 2-00 W. 175 feet to the point of beginning.

This conveyance is subject to Restrictive Covenants of record in Vol. 291 at Page 369. This conveyance is further subject to all easements and rights of way of record.
