KNOW ALL MEN BY THESE PRESENTS, that I, Jeanette D. Burchette,

in consideration of Five and No/100 (\$5.00)-----Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

William S. Burchette and Jeanette D. Burchette, for and during the term of their natural lives, and on the death of either William S. Burchette or Jeanette D. Burchette, then to the survivor, his or her heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, on the east side of Carolina Avenue, and being known and designated as all of Lot No. 16 and the southern 20 feet of Lot No. 17 of the subdivision of the F. M. Harris property known as Highlands as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book C at page 146, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the east side of Carolina Avenue at the joint front corner of Lots Nos. 15 and 16, and running thence with the joint line of said lots, N. 74-30 E. 130 feet to an iron pin at the rear corner of Lot No. 21; thence with the rear line of Lots Nos. 21 and 22, N. 15-10 W. 90 feet to a point, which point is 20 feet north of the joint rear corner of Lots Nos. 16 and 17; thence with a new line through Lot No. 17, S. 74-30 W. 130 feet to an iron pin on the east side of Carolina Avenue; thence with Carolina Avenue, S. 15-10 E. 90 feet to the point of beginning; being the same conveyed to me by J. Monroe Dill by deed dated February 25, 1956 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 546 at Page 165.

It is the intention of this deed to grant a life estate to both grantees herein and upon the death of the first grantee, said property shall vest absolutely and in fee simple in the survivor.

Together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto William S. Burchette and Jeanette D. Burchette, for and during the term of their natural lives, and on the death of either William S. Burchette or Jeanette D. Burchette, then to the survivor, his or her heirs and assigns forever.
