the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Beulah O'Shields Robinson, her heirs and assigns:

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, being known and designated as a portion of Lot 14 of property known as Sans Souci Highlands as shown by plat thereof recorded in Plat Book G at Page 126 and having, according to a recent survey entitled Property of W. P. and Mary M. Hall, dated February 10, 1965, prepared by C. C. Jones, the following metes and bounds, to-wit:
