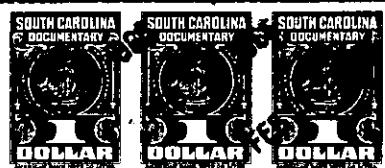

GREENE AND MARY C. GREENE; THEIR HEIRS AND ASSIGNS FOREVER:

All that certain piece, parcel or lot of land in Greenville County, State of South Carolina, on the eastern side of Danburry Drive, near the City of Greenville, being shown as lot No. 132 on plat of Section III WADE HAMPTON GARDENS, recorded in Plat Book YY at Page 179, and described as follows:
