to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said WILLIAM F. KING, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 44 of the Property of Wm. R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book MM at Page 127, and having the following metes and bounds, to wit:

BEGINNING at a point on the Western side of Penarth Street at the joint front corner of Lots 43 and 44 and running thence with the Western side of Penarth Street N 2-50 E 80 feet to a point at the joint front corner of Lots 44 and 45; thence N 87-10 W 175 feet to a point at the joint rear corner of Lots 44 and 45; thence S 2-50 W 80 feet to a point at the joint rear corner of Lots 43 and 44; thence S 87-10 E 175 feet to the point of beginning.

THIS deed is executed subject to existing and recorded restrictions and rights-of-way.
