All that piece, parcel or lot of land situate, lying and being on the Southern side of Archwood Court near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 24 as shown on a plat of Collinwood Park, prepared by J.C. Hill, Engineer, dated October, 1962, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book CCC at page 27, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Archwood Court at the joint front corner of Lots Nos. 23 and 24, and running thence with the line of Lot No. 23 S. 24-30 W. 229.4 feet to an iron pin; thence with the rear lines of Lots Nos. 29 and 28 N. 73-15 E. 151.5 feet to an iron pin at the joint rear corner of Lots Nos. 24 and 26; thence with the rear lines of Lots Nos. 26 and 25 N. 13-0 E. 160 feet to an iron pin on the Southern side of Archwood Court; thence with the Southern side of Archwood Court N. 77-0 W. 75 feet to an iron pin; thence continuing with the Southern side of Archwood Court N. 75-15 W. 15 feet to the point of beginning.
