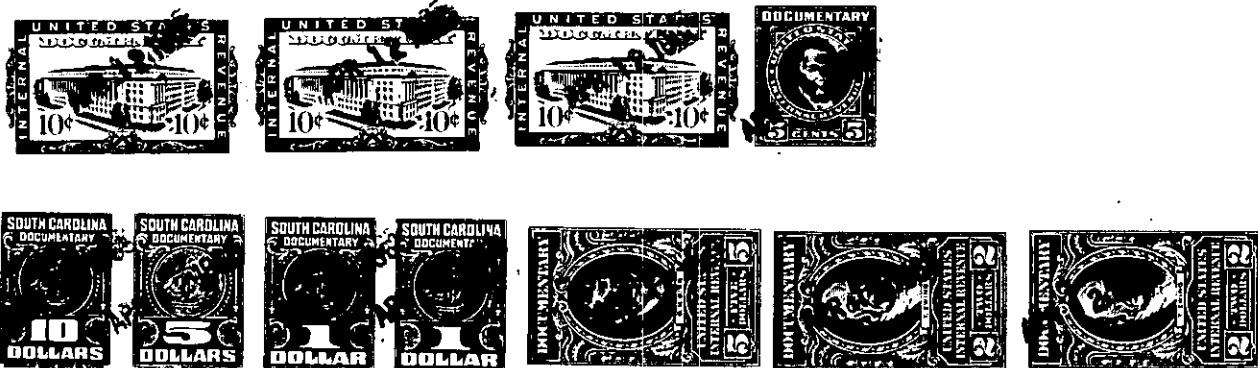

ALL that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot No. 71 according to a plat of Paris Heights made by Piedmont Engineering Service, November, 1950, and recorded in the RMC Office for Greenville County in Plat Book Y, Page 65 and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the northwestern side of Pisgah Drive, the joint front corner of Lots Nos. 71 and 72, which iron pin is set 75 feet southwest of the intersection of Pisgah Drive and an unnamed street, thence northwestern side of Pisgah Drive, S. 48-0 W. 66.7 feet to an iron pin, joint front corner of Lots Nos. 70 and 71, which iron pin is set 1073.5 feet northeast of the intersection of Pisgah Drive and Terrell Drive; thence along the line of Lot No. 70, N. 53-05 W. 156.9 feet to an iron pin, rear corner of Lot No. 70; thence N. 32-38 E. 77.4 feet to an iron pin, corner of Lot No. 72; thence with the line of Lot No. 72, S. 49-11 E. 170.8 feet to the point of beginning.
