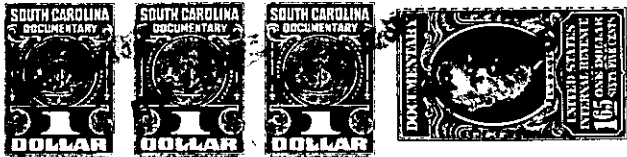
In consideration of One Thousand Five Hundred and No/100 ----- Dollars,
