All of that lot of land in the County of Greenville, State of South Carolina, being shown as a portion of Lot 37 on plat of Pine Brook Extension, recorded in Plat Book W at Page 73 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Edwards Road at the eastern rear corner of Lot 36 and running thence N. 53-45 W. 176 feet to an iron pin; thence N. 73-50 W. 110 feet to an iron pin; thence N. 10-31. 153. feet; thence in a southeasterly direction, approximately S. 60 E. 335 feet, more or less, to an iron pin on the western side of Edwards Road; thence with said Road, S. 12-23 W. 134 feet to the point of beginning. This is a portion of the property conveyed to W. T. & Christine K. Bidwell in Deed Book 416 at Page 540 and Deed Book 585 at Page 391.
