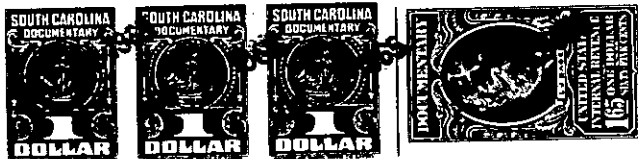
Cecil D. Long and Ruth W. Long, their heirs and assigns forever:
