KNOW ALL MEN BY THESE PRESENTS, that W. JAMES WILLIAMS, AS TRUSTEE

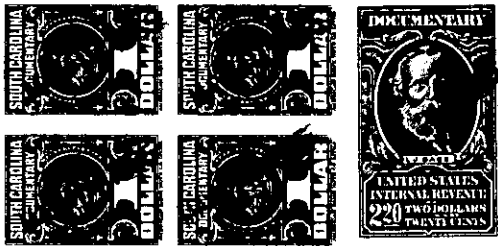
in consideration of Seventeen Hundred Fifty and no/100-----(\$1750.00)-----Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto WILLIAM H. KNIGHT, JR., HIS HEIRS AND ASSIGNS, FOREVER:

ALL that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot #28, part of Avon Park, according to plat by C. C. Jones, dated December 1956, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book KK, at Page 71, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Avon Drive, joint front corner lots #28 and #29, running thence along the joint line of these lots, S. 84-18 E. 175 feet to an iron pin; thence N. 5-42 E. 90 feet to an iron pin at the joint rear corner lots #28 and #27; running thence along the joint line of said lots, N. 84-18 E. 175 feet to an iron pin on the eastern side of Avon Drive; thence along the eastern side of Avon Drive, S. 5-42 W. 90 feet to an iron pin, point of beginning.

This deed is executed pursuant to the power and authority contained in the Trust Agreement recorded in the R. M. C. Office for Greenville County in Deed Vol. 568, at Page 169.
