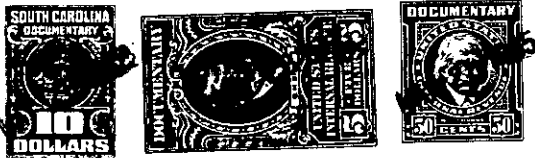
KNOW ALL MEN BY THESE PRESENTS, that I, J. D. GRIFFITH,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto BILLY MAC HARVEY AND MILDRED W. HARVEY, THEIR HEIRS AND ASSIGNS,

FOREVER,
ALL THAT PIECE, PARCEL OR TRACT OF LAND SITUATE, LYING AND BEING IN DUNKLIN TOWNSHIP, GREENVILLE COUNTY, SOUTH CAROLINA, BEING KNOWN AND DESIGNATED AS THE 24.65 ACRE TRACT OF LAND AS SHOWN ON A PLAT OF "PROPERTY OF MITCHELL C. MOORE," PREPARED BY DALTON & NEVES, ENGINEERS, DATED APRIL 1941, AND RECORDED IN THE RMC OFFICE FOR GREENVILLE COUNTY, SOUTH CAROLINA, IN PLAT BOOK 00 AT PAGE 163, AND BEING A PORTION OF TRACT NO. 2 OF THE HYRAM COOLEY ESTATE, AS SURVEYED AND PLATTED BY W. D. NEVES, ENGINEER, AND BEING A PORTION OF THE TRACT OF LAND CONVEYED TO D. C. AND LILA OWENS BY E. INMAN, MASTER, BY DEED BEARING DATE OF DECEMBER 17, 1919, THE SAID E. INMAN, MASTER, CONVEYED TO D. C. AND LILA OWENS 36.65 ACRES, MORE OR LESS, AND THE SAID D. C. AND LILA OWENS CONVEYED FROM SAID TRACT THE TWELVE (12) ACRES, MORE OR LESS, AND IT IS THE INTENTION OF THIS DEED TO CONVEY TO THE GRANTEE HEREIN ALL OF THE REMAINDER OF SAID TRACT. REFERENCE IS HEREBY CRAVED TO THE MOORE PLAT AND TO THE COOLEY PLAT FOR A MORE COMPLETE DESCRIPTION OF THE LAND HEREIN CONVEYED BY METES AND BOUNDS AND COURSES AND DISTANCES.

THIS IS THE SAME LAND CONVEYED TO ARTHUR L. CHILDRESS AND SARAH E. CHILDRESS BY DEED DATED SEPTEMBER 29, 1958, AND IS ALSO THE SAME LAND DESCRIBED IN A CONTRACT WHEREBY ARTHUR L. CHILDRESS AND SARAH E. CHILDRESS AGREED TO SELL THE SAME TO J. D. GRIFFITH, SAID CONTRACT BEING RECORDED IN THE SAID RMC OFFICE IN DEED BOOK 691 AT PAGE 225.
