to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto ROY F. WILSON AND VIRGINIA LEE WILSON:

All that piece, parcel or lot of land situate, lying and being on the Western side of Riley Road near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 35, Section "D", as shown on a Final Plat of Riley Estates, prepared by Webb Surveying & Mapping Co., dated July, 1964, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book BBB at page 13, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Western side of Riley Road at the joint front corner of Lots Nos. 35 and 36, and running thence with the line of Lot No. 36 N. 64-00 W. 170.5 feet to an iron pin; thence with the line of Lot No. 41 N. 20-00 E. 100.6 feet to an iron pin at the joint rear corner of Lots Nos. 31 and 35; thence with the line of Lot No. 31 S. 64-00 E. 181 feet to an iron pin on the Western side of Riley Road; thence with the Western side of Riley Road S. 26-00 W. 100 feet to the point of beginning.

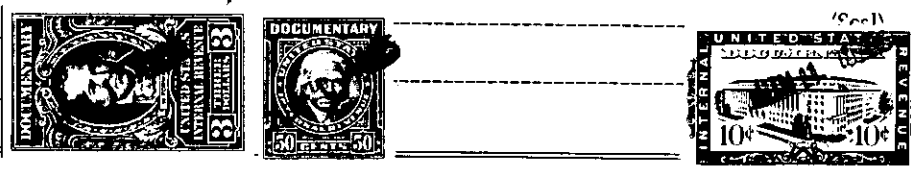
TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.
