the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Jack S. Pruitt, Jr. His Heirs and Assigns forever:

ALL that lot of land in the County of Greenville, State of South Carolina, near Greenville, S. C., shown as Lot 10 on plat of Pinehurst of record in the R. M. C. Office for Greenville County in Plat Book PP at Page 39, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin in the western side of Paris View Drive at the joint front corner of Lots Nos. 9 and 10, which iron pin is situate 75 feet north of a curved intersection of Merrydale Lane and running thence S. 89-02 W. 180 feet to an iron pin; thence N. 0-58 W. 93.2 feet to an iron pin; thence S. 89-58 E. 180 feet to an iron pin at the joint front corner of Lots Nos. 10 and 11, on the western side of Paris View Drive; thence with the western side of said Drive, S. 0-58 E. 90 feet to the point of beginning, Paris View Drive is now known as Montis Drive.
