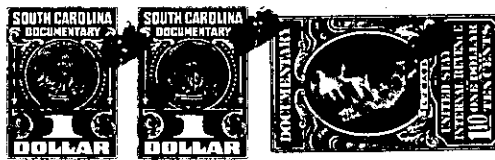
KNOW ALL MEN BY THESE PRESENTS, that I, Ruby Childs, of State and County aforesaid
