the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto D. U. Mauldin, his heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Paris Mountain Township, on the southeast side of New Perry Road, being known and designated as a portion of Lot No. 2 and a portion of Lot No. 3 of a subdivision of the property of Ruth B. Mauldin as shown on plat thereof prepared by Terry T. Dill, Surveyor, and recorded in the R. M. C. Office for Greenville County in Plat Book II, at Page 145, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeast side of a county road, now known as New Perry Road, in the front line of Lot No. 2 at the corner of a lot heretofore conveyed by the grantor to Robert W. Kuhn, and running thence along the southeast side of said road, S. 40-18 W. 110 feet to an iron pin in the front line of Lot No. 3 at the corner of a lot heretofore conveyed by the grantor to William S. Mauldin; thence along the line of that lot, S. 39-38 E. 139.3 feet to an iron pin in the rear line of Lot No. 3; thence along the rear lines of Lots Nos. 3 and 2, N. 40-22 E. 110.1 feet to an iron pin at the rear corner of the Kuhn lot; thence along the line of that lot, N. 39-52 W. 139.66 feet to the beginning corner; being a portion of the property conveyed to me by Dorothy D. Peigler by her deed dated May 31, 1955 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 521, at Page 529.
