the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Elijah Kenneth Gibson and Ruth Juanell S. Gibson, their heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, near Mauldin, on the northern side of West Golden Strip Drive being known and designated as Lot No. 7, Block B, on plat of Property of Mrs. B. E. Greer recorded in the R. M. C. Office for Greenville County in Plat Book "MM", at Page 176 and having, according to said plat, the following metes and bounds, to-wit:
