KNOW ALL MEN BY THESE PRESENTS, that I, Elizabeth R. Yeomans,

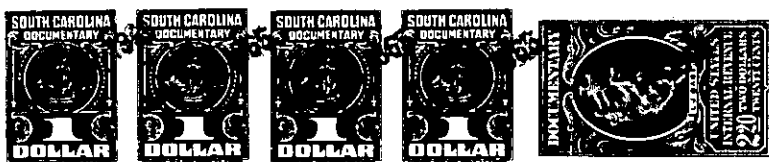
