sold and released, and by these presents does grant, bargain, sell and re-
lease unto PEGGY J. BRACKETT

Grantee(s), and to the
heirs and assigns of said Grantee(s), the following described real estate
situate in the County of GREENVILLE, State of South Carolina, to wit:

All that lot of land in the County of Greenville, State of South Carolina, known and
designated as Lot No. 33 on plat of Woodfields subdivision recorded in plat book S,
Page 7, of the R. M. C. Office for Greenville County, South Carolina, said lot having
a frontage of 70 feet on the southeast side of Ridgeway Drive, a depth of 211.1 feet
on the southwest side, a depth of 216.7 feet on the northeast side, and a rear width
of 70.2 feet.
