the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Agnes B. Hunnicutt and Fay M. Mitchell, their heirs and assigns, forever:

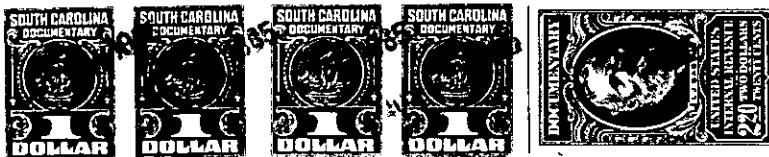
ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lots No. 82, 83 and 84 as shown on a Plat of Pinewood Estates by H. S. Brockman, Surveyor, dated November 7, 1958 and recorded in the R. M. C. Office for Greenville County in Plat Book MM, at Page 55, and having according to said plat the following descriptions, to wit:

BEGINNING at an iron pin on Pinewood Drive at joint front corners of lots 84 and 85 and running thence 270 feet, more or less, with Pinewood Drive to an iron pin at joint corners of Pinewood Drive and County Road; running thence 170 feet, more or less, along County Road and side line of lot 82 to an iron pin; running thence along the rear lines of lots 82, 83 and 84, 270 feet to an iron pin at joint rear corners of lots 84 and 85; running thence 170 feet with the side line of lot 85 to the iron pin on Pinewood Drive, the point of beginning.

NO residence to cost less than Ten Thousand (\$10,000) Dollars shall be erected on any lot; no residence shall be erected on lots nearer than thirty-five (35) feet to the front line; no residence shall be built on any lot unless said lot has 70 feet, or more, frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks; all lots to be used for residential purposes only.

THIS conveyance is subject to all easements and rights of way of record.
