Know All Men by These Presents:

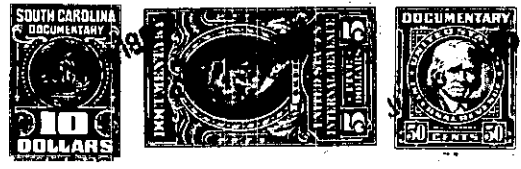

ALL my undivided one-fourth interest in and to all that certain piece, parcel and lot of land lying and being situate on the corner of East Washington and Spring Street in the City of Greenville, County and State aforesaid, said lot being known and designated as Lot No. 6 upon a plat recorded in the Office of RMC for Greenville County in Plat Book C, page 59, and being the same lot conveyed to C. B. Martin by J. W. Norwood by his deed dated December 23, 1919 and recorded in the RMC Office for Greenville County in Book 66, page 60, and having the following courses and distances as shown on said plat and as mentioned in said deeds:
