unto M.G. PROFFITT, INC., its Successors and Assigns forever,

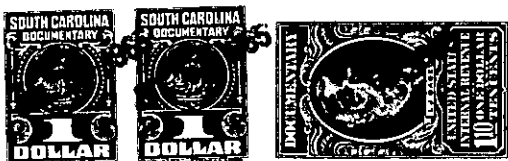
ALL that lot of land with improvements lying on the western side of
Wilshire Drive in the City of Greenville, Greenville County, South Carolina,
being shown as Lot No. 4 on a Plat entitled "Resubdivision of Lots 46 through
56, Stone Estates, Unit No. 2, Greenville, S.C.", made by Piedmont Engineering
Service dated February 2, 1950, and recorded in the R.M.C. Office for said
County and State in Plat Book 14, Page 87, and having according to said Plat
the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Wilshire Drive (formerly
known as Brookwood Drive) at the joint front corners of Lots Nos. 3 and 4, and
running thence along Wilshire Drive S. 11-22 W. 70.5 feet to an iron pin; thence
N. 78-38 W. 160 feet to an iron pin; thence N. 11-22 E. 70.5 feet to an iron
pin; thence S. 78-38 E. 160 feet to an iron pin, the beginning corner.

The above described property is the same conveyed to the grantors herein
by deed of Raymond H. Loper recorded in the R.M.C. Office for said County and
State in Deed Book 6577, Page 166, and is hereby conveyed subject to utility
rights-of-way, easements and building restrictions of public record.

As a part of the consideration for this deed, the grantee assumes and
agrees to pay in full a note and mortgage covering the above property in favor
of C. Douglas Wilson & Co. recorded in the R.M.C. Office for said County and
State on February 17, 1959, in Mortgage Book 776, Page 39, which has a present
balance due in the sum of \$ 10,145.02.
