GILBERT R. PORTER AND ELLE MAE B. PORTER, THEIR HEIRS AND ASSIGNS, FOREVER:

All that certain piece, parcel or lot of land in the town of Mauldin, County of Greenville, State of South Carolina, being shown and designated as Lot No. 7, on plat of property of J. O. Shaver, recorded in the RMC Office for Greenville County, S. C., in Plat Book "LL", at Page 17, said plat being revised and recorded in Plat Book "LL", at Page 20, and having according to said plat the following metes and bounds to wit:

BEGINNING at an iron pin on the northwest side of Shaver Drive at the joint front corner of Lots Nos. 7 and 8, and running thence N. 44-48 W. 144 feet to an iron pin; thence running N. 44-01 E. 100 feet to an iron pin; thence running S. 44-48 E. 144 feet to an iron pin on Shaver Drive; thence with Shaver Drive S. 44-01 W. 100 feet to the point of BEGINNING.
