the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Richard Ivanhoe Bowles, His Heirs and Assigns,

All of that certain piece, parcel or tract of land situate, lying and being approximately two miles East of Table Rock Reservoir and containing 13.6 acres, more or less, according to a plat of the property of G. T. S. Ferguson made by T.Craig Keith, Reg. L. S., November 6, 1964, and according to said plat being more particularly described as follows:

BEGINNING at an iron pin on the line of tract number One on the North side of a paved road and running along said paved road N. 78-45 W. 630 feet to an iron pin; thence S. 13-30 W. 185 feet to an iron pin; thence S. 45 E. 240 feet to an iron pin; thence S. 3 W. 76 feet to an iron pin; thence along the meanderings of a stream as the line from points (A) to (B), as indicated on said plat, 847.8 feet to an iron pin on the banks of South Saluda River; thence along the banks of South Saluda River the following courses and distances: N. 87 E. 200 feet to an iron pin; East 150 feet to an iron pin; S. 72-30 E. 105 feet to an iron pin joint corner of tracts four and five; thence along the line of tract number four, N. 11 E. 1039 feet to an iron pin on the North side of a paved road, the beginning corner.

While the description of the within property along the South Saluda River gives the courses and distances as shown on the above referred to plat the property line goes to the center of the South Saluda River and it is the intent of the grantors herein to convey all of their right, title and interest in said property to the center of the South Saluda River.

It is further understood that while this description extends to the North side of the right-of-way of the paved road it is the intent of the parties to exclude the right-of-way of the South Carolina State Highway Department.
