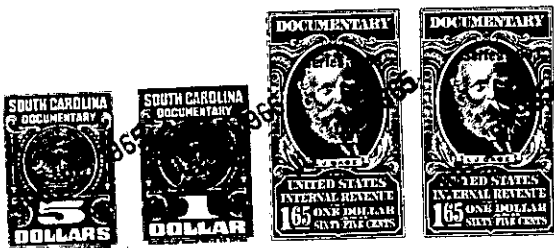
his, her or their heirs or assigns forever:
