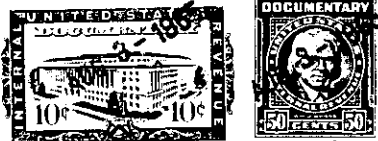

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

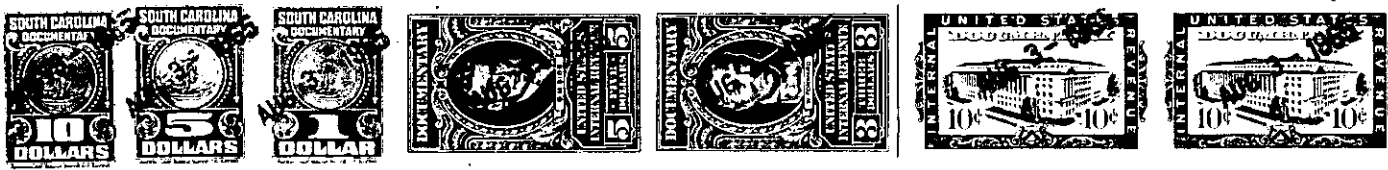
Sue O. Harvey, her heirs and assigns:

ALL those certain pieces, parcels or lots of land in the City of Greenville, County of Greenville, State of South Carolina, situate on the North side of East Washington Street, being known and designated as Lots No. 82 and 83 of Block F as shown on plat of East Park prepared by W. A. Adams and recorded in the R.M.C. Office for Greenville County, in Plat Book A at page 383 and having in aggregate, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the North side of East Washington Street at joint corner of Lots Nos. 70 and 83, which point is 269 feet in a westernly direction from the intersection of East Washington Street and Laurens Road and running thence with the North side of East Washington Street, S. 72-30 W. 121.4 feet to the joint corner of Lots Nos. 81 and 82; thence with the joint line of said lots, N. 74-30 W. 167 feet to a point in the line of Lot No. 77; thence N. 72-30 E. 21 feet to a point in the rear line of Lots No. 73; thence S. 40-30 E. 195.1 feet to the beginning corner.

Gore died on December 7, 1962 and by will left the above described property to Grover C. Gore. Grover C. Gore subsequently died on August 22, 1963 and by his will left the above property to Madolyn Gore Putnam, the grantor herein.
