in consideration of \$5.00 and Love and Affection Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto BEULAH S. TANKERSLEY, her heirs and assigns forever,

ALL that piece, parcel or lot of land situate, lying and being in Cleveland Township, County and State aforesaid, known and designated as LOTS NOS. 38, 39 and 40 of a Subdivision known as Hart Valley Haven, owned by Imogene T. Osteen and David W. Osteen and being shown on plat thereof made by J. C. Hill, Surveyor on March 10, 1955 and recorded in the RMC Office for Greenville County in Plat Book EE, at page 137. Reference to which is hereby made and having the following metes and bounds:

BEGINNING on the rear corners of Lots Nos. 37 and 38 on the North side of Oil Camp Creek and running with the common line of said lots, N. 33-30 West 190 feet to the edge of County Road; thence following said road, N. 63-40 East 60 feet; thence N. 73-30 East 60 feet; thence S. 84-00 East 60 feet to the East line; thence following said East line, S. 32-15 East 288 feet to the North side of Oil Camp Creek; thence following the meanderings of said creek in a Westerly direction 239 feet, more or less, to the point of beginning.
