the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto George D. Johnson and Mary B. Johnson, their heirs and assigns forever

All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, being known and designated as Lot 9 on plat of property of Belle Meade recorded in Plat Book EE, Pages 116-117, in the R.M.C. Office for Greenville County, and having according to a more recent survey by J. C. Hill dated March, 1959, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Williamsburg Drive at joint front corner of Lots 9 and 10, said pin being 40.1 feet northeast of the intersection of Brook Forest Drive and Williamsburg Drive, and running thence with Williamsburg Drive, N. 11-33 E. 70 feet to an iron pin; thence with the line of Lot 8, S. 78-27 E. 150 feet to an iron pin; thence S. 11-33 W. 70 feet to an iron pin, joint rear corner of Lots 9 and 10; thence with the line of Lot 10, N. 78-27 W. 150 feet to the point of beginning.

This being the same property conveyed to the grantors herein by deed recorded in Deed Book 738 at page 90.

As a part of the consideration, the grantees herein assume and agree to pay the balance of that certain mortgage in favor of Prudential Insurance Company of America recorded in the RMC Office for Greenville County in Mortgage Book 781 at page 353 and having a present balance of \$10,862.00.
