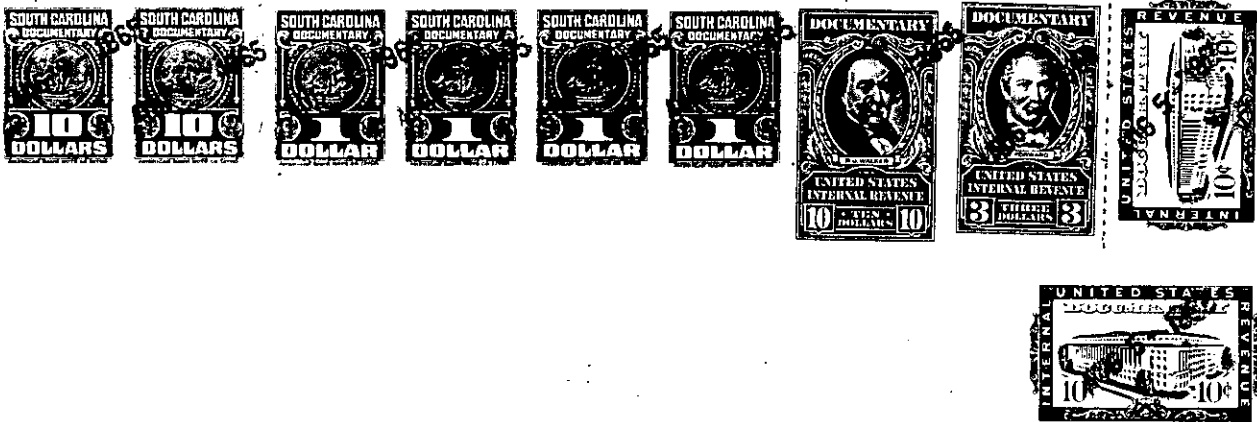

Office for Greenville County in Plat Book XX at pages 44 and 45, and having according to said plat the following metes and bounds, to-wit:
