KNOW ALL MEN BY THESE PRESENTS, that

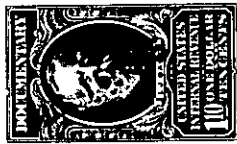
in consideration of ONE THOUSAND AND NO/100----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto JOHN M. JOLLY, His Heirs and Assigns:

ALL that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot 294, Section 3, Belle Meade Sub-division, which plat is recorded in the RMC Office for Greenville County, South Carolina, in Plat Book GG, page 187, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Lancaster Lane, joint front corner Lots 293 and 294; and running thence along Lancaster Lane, N. 44-45 W. 80 feet to an iron pin, joint front corner Lots 294 and 295; thence N. 45-30 E. 127.3 feet to a point; thence along the line of Lot 296, N. 66-0 E. 79.1 feet to an iron pin; thence N. 26-13 E. 65 feet to an iron pin, joint rear corner Lots 293 and 294; thence S. 42-38 W. 181.3 feet to an iron pin, the point of beginning.

As a part of the consideration hereof, the Grantee agrees to assume and pay, according to its terms, that certain note and mortgage given to C. Douglas Wilson & Co. on which there is a balance due of \$16, 982.77; said mortgage being recorded in Mortgages Volume 851, page 265.
