the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto W. Lewis Stover, his heirs and assigns

ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being shown and designated as Lot No. 93 on plat of Drexel Terrace dated April 1, 1961 and prepared by Piedmont Engineering Service, recorded in the office of the R.M.C. for Greenville County in Plat Book QQ at page 177, and being more particularly described with reference to said plat as follows:

BEGINNING at a point on the easterly side of Dellrose Circle, joint front corner of Lots 93 and 94 and running thence along Dellrose Circle N. 13-56 E. 110 feet to a point, joint front corner of Lots 92 and 93; thence turning and running along the common boundary of said lots S. 68-40 E. 196.4 feet to a point in the rear line of Lot 87; thence turning and running S. 5-43 W. 62.9 feet to a point, joint rear corner of Lots 93 and 94; thence turning and running along the common boundary of said lots N. 82-20 W. 205 feet to the point of beginning on Dellrose Circle.

Said lot is subject to protective covenants for Drexel Terrace recorded on April 7, 1961 in the office of the R.M.C. for Greenville County in Deed Book 671 at page 355 and to building set-back line as shown on said plat.

This is a portion of the property conveyed to the Grantor herein by deed of W. B. Simmons, recorded on April 3, 1961 in the office of the R.M.C. for Greenville County in Deed Book 671 at Page 155.
