Greenville Memorial Gardens filed in the Office of the Greenville Memorial Gardens, of said Green-

ville County, South Carolina

THAT THIS CONVEYANCE, together with title and interest hereunto, shall remain in the property above described, to and at all times shall be limited to a right of interment only thereinafter and is subject at all times to the rules, regulations and by-laws of the Corporation created in its office, now existing and as which may be hereafter adopted either by amendment, alteration or the adoption of new ones, and which are specifically referred to in the instrument attached, if set forth in full, all of which, together with reservation and restrictions, shall be binding upon the Grantee, his heirs, devisees, assigns, administrators, executors and assigns, and the limited liability as set forth in the contract for purchase.

Nothing herein contained shall be construed to restrict the use of any portion of said Cemetery. Only the Grantee or his heirs, assigns, or in interest of the Grantee, shall be subject to any restrictions heretofore or hereafter concerning the use of any portion of said Cemetery.
