Know All Men by These Presents:

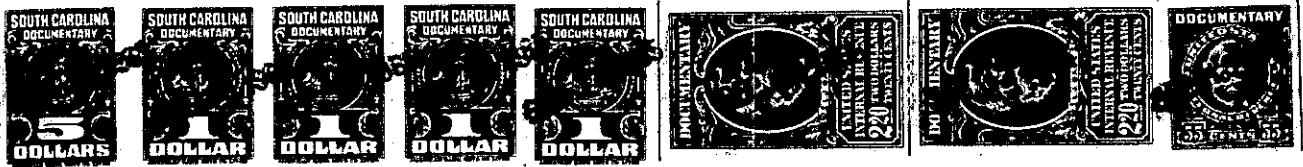
That We, Olen Q. Todd and Fannie P. Todd

in consideration of the sum of Forty-Five Hundred and No/100 (\$4500.00) in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Thomas Smith and Louise Smith:

All that tract or lot of land in Gantt Township, Greenville County, State of South Carolina, about six and one-half miles South of the City of Greenville, on the South side of East Gantt Street, and being known as Lot No. 40, as shown on plat of property of Albert Q. Taylor made by Dalton & Neves, May, 1946, and recorded in the office of the R. M. C. for Greenville County in Plat Book P, Page 49 and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the South side of East Gantt Street, which pin is 492.8 feet east from the intersection of East Gantt Street and the Augusta Road, joint corner of Lots Nos. 41 and 40, and running thence along the South side of East Gantt Street, S. 48-44 E. 100 feet to an iron pin, joint front corner of Lots Nos. 40 and 39; thence along the line of Lot No. 39, S. 40-15 W. 148.9 feet to an iron pin, joint rear corner of Lots Nos. 39, 35, 34 and 40; thence along the rear line of Lot No. 34, N. 53-42 W. 100.3 feet to an iron pin, joint rear corner of Lots 34, 33, 41 and 40; thence along the line of Lot No. 41, N. 40-15 E. 152.6 feet to the point of beginning and being the same property conveyed to the grantors by John J. Byrne and Kathryn W. Byrne by deed dated April 16, 1963 and recorded in the R. M. C. Office for Greenville County in Deed Book 721, Page 51.
