in consideration of the sum of Three Thousand Eight Hundred and No/100 (\$3,800.00)----- DOLLARS,

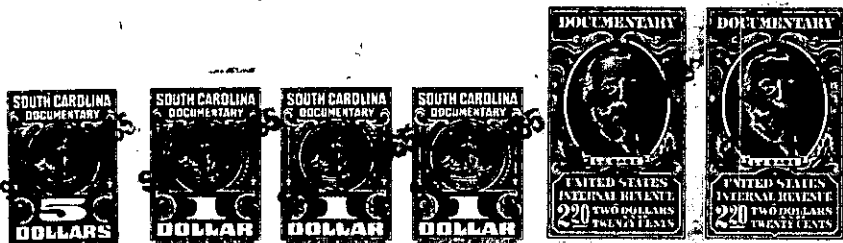
