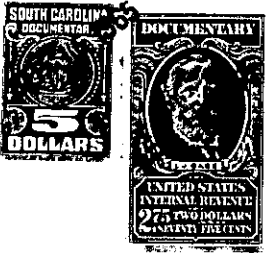
KNOW ALL MEN BY THESE PRESENTS, that R. Buford Landers
